Responsibilities include plowing/shoveling snow, spreading salt, mowing the library properties, keeping the campus safe and free of debris, planting flowers, landscaping, driveway, sidewalk, and exterior structure upkeep, painting, building repairs, general maintenance, special projects and other duties as assigned. The Library is a proud feature of the community and must always appear inviting and attractive to our residents.

WORKING CONDITIONS & REQUIREMENTS CON'T
